#### **UTILITY RATE CHANGES**

Effective January 1, 2018; some of the City of Barnesville utility rates are changing:

- Sewer volume charges increase to \$5.38
- · Water usage charge increase to \$2.94
- Water, Sewer, Stormwater replacement funds each increase to \$2.94 month.

These changes will be reflected on the utility bills which residents receive in February.

Also on the February utility bills garbage service will increase to \$17.65 per month; while the senior rate will increase to \$16.37.

Mayor Prim called this regular meeting to order at 7:00 p.m. Members present were Council members Jason Rick, Larry Davis, Jr. Betty Strom, David Brown, Don Goedtke, and Brad Field.

11-13-17-01 Motion Davis, second Strom to approve the agenda as presented, with the additions of the appointment of Paula Dobmeier to the HRA Board of Commissioners and approval of the Barnesville Fire Dept. gambling permit for January 26, 2018. Motion carried.

11-13-17-02 Motion Rick, second Goedtke to approve the consent agenda. Motion carried

11-13-17-03 Motion Davis, second Rick to open the public hearing on property maintenance assessments at 7:04 p.m. Motion carried. 11-13-17-04 Motion Davis, second Rick to close the public hearing on the property maintenance assessments at 7:16 p.m. Motion carried.

11-13-17-05 Motion Davis, second Rick to certify the charges to the County Auditor for the 2017 property maintenance assessments. Motion carried.

11-13-17-06 Motion Goedtke, second Brown to table the property maintenance violation at 508 6th Street NW until the December regular council meeting. Motion carried.

11-13-17-07 Motion Rick, second Strom to approve the proposed Comprehensive Plan. Motion carried.

# **TOILETS ARE NOT TRASH CANS!**

In recent months, PeopleService staff have been finding an increased amounts of "materials" including **rags** in the City's sewer system.

Some items may be labeled "flushable" but are should NOT be flushed as they do not break down in the sanitary sewer system. As these items accumulate within the sewer pipes, they restrict the flow and eventually cause blockages. This leads to sanitary sewer backups and/or overflows, which are harmful to the environment and costly for both homeowners and the city.

# THE ONLY ITEMS YOU SHOULD FLUSH DOWN THE TOILET: Bodily wastes & toilet paper!

Do not flush the following items:

- Baby wipes/diapers
- Tampon applicators
- Cotton swabs
- Kitty litter
- Sponges
- Cigarette butts
- Oils and grease

- · Rags & towels
- Kleenex
- Syringes
- Aquarium gravel
- · Sanitary napkins
- Hair
- · Unused medications

If we all work together we can make sure our sewer system stays in good working order!
