PRESIDENTIAL PRIMARY ELECTION TO BE **HELD ON TUESDAY. MARCH 3. 2020!**

The 2020 Presidential Nomination Primary will be fifth in the state's history! The last Presidential Primary in the State of Minnesota was held in 1992.

The polls will be open from 7:00 a.m. until 8:00 p.m. on Tuesday, March 3rd at the Sr. Citizen Center, 501 2nd Ave NE. Absentee ballots are available at the Clay County Auditor's office. Residents may contact the Auditor's office at 218.299.5006 for an absentee ballot.


The voter will be given a presidential "primary" ballot with only those party's candidates on the ballot. There will only be the one office (president) on the ballot and it will be one name only (not a team). Per MN State Statute, the voter must declare their political party preference to the election judge before a ballot will be issued.

Each political party will have their own ballot, there will be two different ballots. The voter cannot change party once a ballot has been received. The Political Parties are the Republican Party, and Democratic-Farmer-Labor Party.
