RESTRICT UNWANTED PHONE SOLICITATIONS REGISTER FOR DO NOT CALL LIST!

You have a choice regarding telemarketing calls. If your number is listed on the Do Not Call registry, all commercial telemarketers, except for businesses with whom you have an existing relationship or certain non-profit and political organizations, can not call you.

Register your residential telephone number, including wireless numbers, at no cost, online on the national Do-Not-Call Registry at www.donotcall.gov. Registration will be effective 31 days after registration. Your number will remain

on the registry permanently. You are allowed to remove your number from the registry at any time.
