Barnesville residents are reminded that Election Day is **Tuesday, November 3**. The polls will be open from 7:00 am to 8:00 pm at the Senior Citizens Center located at 501 2nd Ave. NE. Please bring a drivers license with your current address. If the address is not current on your photo ID you also need a utility bill with a

BARNESVILLE CITY COUNCIL Regular Meeting • September 14, 2020

Mayor Rick called this regular meeting to order at 7:00 p.m. Members present were Council members Scott Bauer, Tonya Stokka, Dawn Stuvland, Alyssa Bergman, Don Goedtke, and Brad Field

09-14-20-01 Motion Stokka, second Goedtke to approve the agenda as presented, with the addition of the CUP extension request. Motion carried.

09-14-20-02 Motion Stokka, second Bergman to accept the consent agenda. Motion carried.

09-14-20-03 Motion Field, second Stokka to approve the 20201 Levy Resolution. Voted aye: Stokka, Goedtke, Stuvland, Bauer, Bergman and Field. Voted nay: none. Motion carried.

09-14-20-04 Motion Bergman, second Goedtke to approve the 2021 budget Resolution. Voted aye: Stokka, Goedtke, Stuvland, Bauer, Bergman and Field. Voted nay: none. Motion carried. 09-14-20-05 Motion Field, second Stokka to approve the Change Order No. 6 for the bike trail, in the amount of \$21,709.00, with the funding from the wheelage tax funds. Motion carried.

09-14-20-06 Motion Goedtke, second Field to approve the Purchase Agreement with Keith Ernst and Debora Egge for a land purchase: A portion of Lot 2, Block 1, Ermas Garden Subdivision, City of Barnesville, County of Clay, in the amount of \$93,315.30, calculated as 23,927 square feet at the rate of \$3.90 per square foot. Motion carried.

09-14-20-07 Motion Goedtke, second Stuvland to approve the CARES Funds Resolution. Voted aye: Stokka, Goedtke, Stuvland, Bauer, Bergman and Field. Voted nay: none. Motion carried. 09-14-20-08 Motion Goedtke, second Bauer to approve the CARES funding for Home Based Businesses, with a deadline of October 8, 2020. Motion carried.

09-14-20-09 Motion Field, second Stokka to authorize City Administrator Mike Rietz and EDA Director Karen Lauer to review the applications for the CARES funding for Home Based Businesses, and dispense the funds immediately upon approval of application. Motion carried.

09-14-20-10 Motion Bauer, second Bergman to approve the purchase of new chairs for the City Council Chambers and two staff chairs, with the funding from the CARES Act Funding in the amount of \$5,458.60. Motion carried.

09-14-20-11 Motion Field, second Stuvland to approve the CUP Permit extension until November 1, 2020 for Mr. Chad Jegtvig. Motion carried.

09-14-20-12 Motion Bergman, second Stokka to approve the Resolution of the Adoption of the Clay County All-Hazard Mitigation Plan. Voted aye: Stokka, Goedtke, Stuvland, Bauer, Bergman and Field. Voted nay: none. Motion carried.

CALLER ID "SPOOFING" NOTICE

Caller ID service is currently susceptible to fraud known as Caller ID "spoofing". The term Caller ID Spoofing refers to a practice whereby the calling party uses commonly available technology to falsify the number of the telephone line from which the call is made, the name of the calling party, or both as they appear on the called party's Caller ID screen. This practice has the potential for fraud and harm to the called party.

To protect yourself, do not take what the Caller ID screen displays for granted. If what the caller is saying does not seem legitimate, do not divulge personal information until you can verify the source, by hanging up and calling them back on a verified number (from a mailed statement or printed directory).

TELEPHONE ASSISTANCE AVAILABLE

Lifeline and Link-up are federal and state assistance programs which reduce telephone

bills for qualified low income customers.

Lifeline offers a monthly credit up to \$16.25 per month and the Link-up



program reduces installation charges for qualified low income customers. You may qualify for these programs if you participate in SSI, Energy Assistance, Temporary Assistance for Needy Families, Medicaid, Food Stamps, Free School Lunch or if your household income is below 135% of the Federal Poverty Guidelines.
