### **2022 Utility Rate Changes**

Each year Barnesville residents see a few small changes to utility rates. These increases help cover the cost of the new water tower and lagoons.

#### On the bill you receive the end of January:

- Sewer volume charges increase to \$6.05
- Water usage charge increase to \$3.31
- · Water, Sewer, Stormwater replacement funds each increase to \$3.31 month.
