STAGE 3 WATER RESTRICTIONS!

On July 20, the Barnesville City Council took action to implement STAGE 3 Water Restrictions effective immediately.

STAGE 3 WATER RESTRICTIONS





- NO yard watering- except for lawns sodded or seeded this year
- Trees, shrubs and gardens may be watered <u>following Odd-Even Rule</u>, handheld devices only, from 6:00-9:00 am and 7:00-10:00 pm
 - on even numbered days, even numbered homes - on odd numbered days, odd numbered homes
- NO Filling of Swimming Pools
- NO Washing of Vehicles
- HOURS for the Kava Family Splash Pad will be reduced to 2-5 pm, 7 days a week

This action was taken due to MN Department of Natural Resources (DNR) request for towns to restrict outdoor water use because of significant drought conditions. Plus, our water tower will be out of operation for 4 weeks due to maintenance.

THANK YOU for your compliance with these restrictions. As a community we all need to work together to ensure that we have adequate water for fire protection and that we protect the source of our water - the aquifers.
