URGENT!

Many people are running their sump pumps into their floor drain (sanitary sewer) creating challenges for the community!!

Not only is discharging your sump pump into the sanitary sewer illegal, but it endangers your neighbors! The sanitary sewer lines, as well as the City's treatment facilities are unable to handle the volume of water that comes from sump pumps, particularly in the case of heavy rain. The result can be raw sewage backing up in homes.

All sump pumps MUST drain outside into the City's storm sewer system. Please make sure your hose runs in your yard, not the neighbors!

Homeowners who fail or refuse to follow the sump pump ordinance will be subject to a \$100 a month fine.
